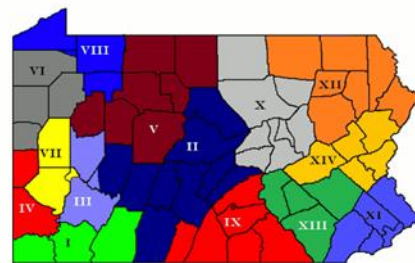

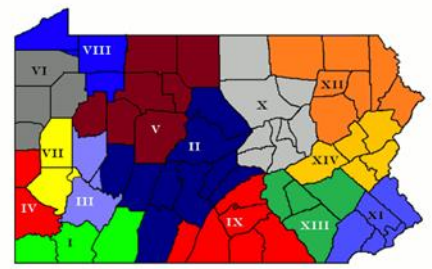
REGISTRATION LINK: USE THIS TO REGISTER FOR THE PJW YOUTH TOURNAMENT!

ELIGIBILITY: All residents from Northampton, Monroe, Carbon, Lehigh, and Schuylkill counties will need to qualify to the State tournament by placing in the top 2 of this tournament. You can compete in this tournament **ONLY** if you LIVE in these counties.

AGE EFFECTIVE DATE: A wrestler's age group classification is determined by his/her age on December 31, 2018. **EXAMPLE:** A wrestler's 11th birthday is 1/1/2019. That wrestler competes in the 9-10 division.

FORMAT: Double elimination (with true second) with awards for the top three finishers in each weight class.

PLEASE UNDERSTAND----- This is the one and only chance to advance to the State Tournament. You will need to place top 2 at this tournament. We will wrestle for a true second in this tournament.

Those who qualify are required to purchase a State Championship Area XIV Singlet. These singlets and T-shirts will be yours to keep after the tournament and the will cost \$80.00. CASH ONLY. These singlets and T-shirts must be worn at the State Championships. ALSO—ALL QUALIFIERS MUST BRING A COPY OF THEIR BIRTH CERTIFICATE for the PJW Committee.

On behalf of the Pennsylvania Junior Wrestling Area XIV committee, we would like to invite you to what we hope will be the best wrestling experience you have this year. This year's Pennsylvania Junior Wrestling Youth Area Championship will be a one day tournament. The top two wrestlers from OUR Qualifier will advance to the State Tournament.

Area XIV will now include only full-time residents of Northampton, Monroe, Carbon, Lehigh, and Schuylkill counties. Please understand that this goes by the county you live in REGARDLESS of where you wrestle.

The PJW STATE CHAMPIONSHIPS will be held at the Petersen Events Center in Pittsburgh on March 16 and 17.

Our goal is to bring the quality and professionalism of the Pennsylvania Junior Wrestling to the local qualifiers so that everyone can enjoy the PJW experience.

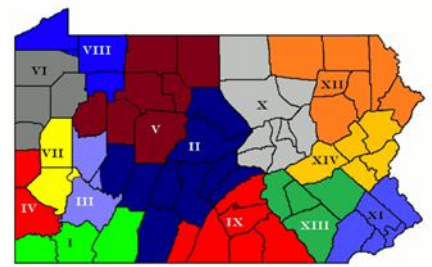
The Area XIV committee is making every effort to assure that the Championship series is the gold standard in youth wrestling. This will be a great tournament, and we are looking for great representation from our area.

RULES AND REGULATIONS

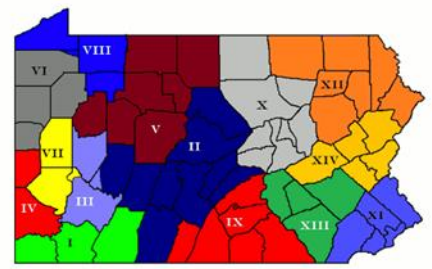
1. Participants may only compete in one qualifying tournament, one weight class and one division.
2. There is no weight allowance.
3. A wrestler cannot wrestle outside his/her age group, unless he/she weighs more than the heaviest weight class in his/her age group.
4. PJW, National Federation and PIAA rules will govern all matches except as follows:
 - All U8, 9-10 and 11-12 bouts in the championship bracket will consist of three periods of 2 - 1 - 1.
 - All Consolation matches will consist of three periods of 1-1-1.
 - Overtime to be 1-30-30-30 ride out (1st point gets choice)
5. **HEADGEAR IS REQUIRED IN ALL PJW TOURNAMENTS**
6. Mouth Guards are recommended for participants with braces.
7. A wrestler's age group classification is determined by his/her age on December 31, 2018.
EXAMPLE: A wrestler's 9th birthday is 1/1/2019. That wrestler competes in the 8-under division.
8. **AGE CHALLENGE RULE** - Challenger and Challenged must provide proof of age. Bring your Birth certificate with you.) Birth certificates or copies of birth certificates will be required of all finalists at the Area XIV Tournament and for all wrestlers competing in the PJW State Championship Tournament.

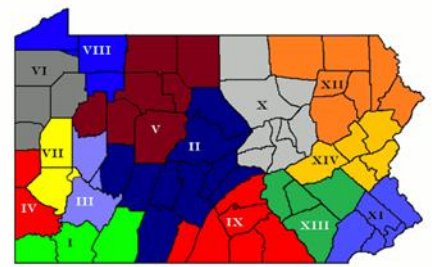

RELEASE AND WAIVER OF LIABILITY AGREEMENT & PARTICIPANT CODE OF CONDUCT

I am voluntarily participating with knowledge of the danger involved, and agree to assume any and all risks of bodily injury, or death, whether those risks are known or unknown.
