- When:** Sunday, January 20, 2019
- Place:** Downingtown West High School Gymnasium ♦ 445 Manor Ave., Downingtown, PA 19335
- Time:** Wrestling will begin promptly at 9:00 A.M. (coaches meeting at 8:30 A.M.)
- Entry Fee:** \$400 per team-checks made payable to Downingtown Wrestling Club.
Each wrestler must have a USA Wrestling card (Tournament Director can arrange purchase) and bring the attached, signed waiver form to weigh-ins. Applications accepted in order of receipt.
Teams are considered entered only upon receipt of payment in full.
- Weight Classes:** 48-52-56-60-64-68-72-76-80-85-90-95-100-110-120-HWT (max. of 165 lbs.)
Teams can consist of 21 members, including 5 alternates.
- Weigh-Ins:** Sunday Jan. 20, 2019 between 7:30-8:30 A.M. ♦ Each team will be assigned a designated weigh-in time.
- Format:** 2 pools of 5 teams, each team will wrestle all other teams within pool. ♦ Placing matches will be cross-over matches for 1st through 8th place ♦ Teams will not wrestle any other team twice.
- Eligibility:** All wrestlers must be from the same rec league program, except upon approval of the Tournament Director; **no club or all-star teams.** ♦ Wrestlers must be in grades K-6, no seventh graders.
- General Information:** Modified PIAA Rules ♦ Bout length 1-1-1 (OT-1 minute sudden death, 30 second ride out) Singlet (or other NFHS approved uniform) and headgear are mandatory.
- Scoring:** PIAA Team Scoring Rules.
- Awards:** Team trophies to the top 3 teams.
- Admission:** Adults \$5.00. Children under 12 free.
Two coaches per team are free (Coaches names are required in advanced).
