- **Coaches must weigh-in the wrestler and write age/weight on left arm prior to competition.**
- Age: Up to 13 years old day of tournament (1st and 2nd year wrestlers only.)
- Best effort is used to pair wrestlers with similar opponents (age, weight and ability)
- All decisions by the tournament director are final!
- High School wrestlers will ref all matches
- Wrestlers will be matched up with each other +/- 5 pounds and +/- 1 year of age
- Wrestlers will wrestle at least 3 matches and there will be three 1 one minute periods
- All wrestlers participating will receive an award ****Nice 9.5" Trophy or Large 2.75 in Medals****
- Coaches meeting at 8:30am, Wrestling will start PROMPTLY at 9:00am
- 2 Coaches per mat, **no parents allowed on mat**
- NO FOOD, BEVERAGES or COOLERS will be allowed in the gym
