Weigh-in: Honor system—No weigh-ins. Please submit weight to a tenth of a pound. Wrestlers must be within two pounds in a singlet and wrestling shoes. Challenges will be at the discretion of the tournament director. NO REFUNDS. Scale will be available for challenges

Format: Round Robin. Madison weight system. Four mats will be used. All bouts 1-1-1. Modified PIAA rules

Rules: Round-Robin tournament each wrestler will wrestle all wrestlers in their weight bracket. Each Division will be sorted by actual weight in groups of 5 or less. Honor weigh in with random weight checks. All registered weights must be actual weights to a tenth of a pound. Singlets & headgear are recommended. Age as of **Nov 17, 2019**. No 7th graders.

Divisions: Pee-wee (5&6), Bantam (7&8), Midget (9&10), Junior (11&12)

Awards: Medals for 1st, 2nd & 3rd.

Entry Fee: \$27.00 entries postmarked by October 30th — \$32.00 for all other entries up until November 17th. Pre- registration only—No Walk-ins & No Refunds. Mail-in entries MUST be **received** no later than November 16th.
