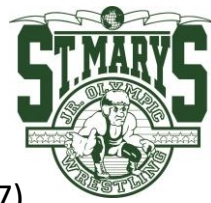


**St. Marys JO Wrestling Annual Scott Neil Memorial Tourney

**Rules/Format:** PIAA Modified – Periods 1-1-1 (1 Minute Overtime, 30 second ride out)

**Time:** Weigh in & skin check: 7:00-8:00 am (Must be within 1lb of listed weight)

**Coaches meeting @ 8:30 am.** Wrestling will start immediately after.

**Age Divisions:** 8&U, 9&10, 11&12. Age as of Jan. 1, 2019.

**Awards:** All 1<sup>st</sup> place winners receive a **24" 3 Column** trophy. All 2<sup>nd</sup> & 3<sup>rd</sup> place winners receive t-shirt.

Wrestlers will be grouped by age and closest weight. Brackets will be combined, if necessary, at our discretion.

**Novice Tourney (1<sup>st</sup> and 2<sup>nd</sup> yr wrestlers )**

**Time:** 11am-12pm skin checks. Novice tourney begins at conclusion of Open tourney.

**Age Divisions:** 6&U, 7&8, 9&10, 11&12. Age as of Jan. 1, 2019.

**Awards:** Medals for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>.

Wrestlers will be grouped by age and closest weight. Brackets will be combined, if necessary, at our discretion.
