

THOMAS JEFFERSON SOUTH HILLS DUAL MEET WRESTLING TOURNAMENT

- Where** TJ High School - 310 Old Clairton Rd, Jefferson Hills, PA 15025
- Time** **Weigh Ins begin** at 8am as a team in the TJ Wrestling Room
Coaches Meeting at 8:30 (location TBD)
Wrestling begins @ 9:00
- Format** Rosters with grade and accomplishments are important to submit because we will be seeding all teams for a first round that will divide teams into two pools. Winners will go in one pool and losers in another. Then teams will wrestle the other teams in their pool. This will guarantee every team four to five dual matches. The team that finishes first in the (winners) A pool, will be the undisputed tournament champion. Then we will wrestle for a true 2nd and a true 4th. True 2nd will be a match between the first place team from the (losers) B Pool vs the 2nd place team in the A Pool. Likewise, the true 4th place match will be between the 2nd place team of the B pool vs the 3rd place team of the A Pool. Top 4 teams will receive a plaque. The only exception would be if either of those matches were already wrestled in the first round then true 2nd / 4th would have already been determined and need not be wrestled again.
- 1st place (4 matches) - Winner of the A Pool
- 2nd place (possible 5 matches) - Winner between 2nd place team from A Pool vs 1st place team of B Pool
- 3rd place (possible 5 matches) - Loser between 2nd place team from A Pool vs 1st place team of B Pool
- 4th place (possible 5 matches) - Winner between 3rd place team from A Pool vs 2nd place team of B Pool
- 5th place (possible 5 matches) - Loser between 3rd place team from A Pool vs 2nd place team of B Pool
- 6th place (4 matches) - 4th place finisher of the A Pool
- 7th place (4 matches) - 3rd place finisher of the B Pool
- 8th place (4 matches) - 4th place finisher of the B Pool
- Eligibility** K-6 grade only. Must be registered in the team's school district. No wrestlers that are on the Middle School / Jr. High team are permitted. No wrestling club teams.
- Rules** PIAA Rules/Officials. Length of matches 1-1-1 with 1 minute sudden victory and 30 second ride out (first point's choice). Captains will report to determine disk toss result and which team presents wrestler first (even/odd matches) as well as who gets 2nd period choice. School singlet and headgear required. Referee and/or Tournament Director's Decisions are final.

Weight Classes Maximum of 22 wrestlers (17 weight classes plus 5 alternates max). A coach MUST be present at the weigh in.

Any wrestler may move up **one** weight class from the weigh in weight regardless of actual weight. Coaches will approve all weigh ins for their team.

Weights: 44, 48, 52, 56, 60, 64, 68, 72, 76, 80, 84, 88, 94, 105, 120, 135, HWT (185 max)

NOTE: We encourage teams to bring extra wrestlers for exhibition matches, however, we will only provide 17 shirts per team. Only rostered wrestlers will wrestle in the dual matches and all wrestlers can wrestle exhibition matches. Please bring your exhibition list with you so we can pair them with wrestlers. Indicate on the list the weight, age, and years of experience on the form.

Weigh-ins Sunday January 20, 8 AM, TJ High School Wrestling Room as a team.

Awards Team trophy & Champion T-Shirt for the 1st place team. Team trophies for 2nd through 4th place. Each Coach will select and an individual will receive a Most Outstanding Wrestler Award (1 per Team).
