- Date/Time:** Saturday, February 16, 2019 - Wrestling begins at 9:00am
Place: Warren Area High School, 345 E. Fifth Avenue, Warren PA. 16365
- Weigh-ins:** Saturday 2/16/2019 - 6:30-8:30am. All Wrestlers will weigh-in the day of the tournament. Wrestlers must also pass a skin and nail check. Wrestlers must be within 1 pound of actual weight on form at weigh-in.
- Who:** Wrestlers up to age 12. Age is as of January 1, 2019. (Birth certificate must be provided if challenged)
- Entry Fees:** **\$27.00 Online Registration.**
DEADLINE for entries is Wednesday February 13, 2018 at 8:00 pm.

- Spectator fees:** Adults \$5.00 (All coaches pay), Students and Senior Citizens \$2.00, 6 & under free. Cafeteria will be available all day.
- Rules:** Silent Bouts. Wrestling PERIODS will be 1-1-1 for all weights. PIAA modified rules, overtime 1 minute sudden death; 30 second ride out. Headgear is mandatory. All seeding will be done by tournament director as needed to accommodate for no more than five wrestlers per round robin class. Every effort will be made to give each wrestler at least three matches. Wrestlers may double bracket, only if in different age class; must pay two fees. Matches will not be held for wrestlers that double bracket.
- Divisions:** 6&U, 7&8, 9&10, and 11&12.
