Location: Westfield Academy and Central School, 203 East Main Street, Westfield NY 14787

Please note this is for 1<sup>st</sup> and 2<sup>nd</sup> year wrestlers only Ages 4 –12

Parking at main entrance. Additional parking is available at bus garage located behind the main school building. Take Cass Street (2 blocks west from school) follow until you see the back of school on the right. You will need to walk up sidewalk to main entrance.

**Weigh-Ins:** 7:00am – 8:30am (Wrestling starts at 9:00am)

**Rules:** Folk Style New York State, headgear mandatory, hair caps required for longer hair

**Periods:** 1-1-1 minute, sudden death 1-minute overtime

**Awards:** Each participant will be awarded a trophy

### EXPLANATION OF TOURNAMENT

This is a beginning-wrestling tournament to provide match experience to new wrestlers. Every effort is made to pair the wrestlers to each other's AGE, WEIGHT & EXPERIENCE. Each wrestler will receive a bout sheet that he/she will carry for the day. All wrestlers will wrestle 3 individual matches. If in the matches a wrestler gets pinned within 30 seconds, the official will restart the match in neutral position, (allowing more mat time) and the wrestler who pinned his/her opponent will be awarded the win. When the Wrestler has completed his/her 3 matches they will be awarded their trophy.
